Reference is invited to clarification regarding FAQs circulated vide HQrs. Office Circular dated 20.04.2023. As per Sl. No. 6 of the said circular it was clarified that **“the questions will be reflected in the opted language only which the candidate has selected during registration i.e. Hindi or English. Different language option may be exercised for each paper.”**

2. However requests/representations have been received for providing the question paper in bilingual format i.e both in Hindi and English. Accordingly, it has been decided by the Competent Authority that **“the question papers will be reflected in both the languages i.e. in Hindi and English in Paper I, II, IV & V whereas in Paper III (Language Skills & Office Communication) the questions will be reflected either in Hindi or in English as opted by the candidates.” This may be brought to the notice of all concerned.**

3. Further it reiterated that the online registration of the candidates will be closed on 27.04.2023. As such all PCsDA/CsDA are requested to invariably forward the Copy of the Board Proceedings regarding screening of candidature & **details of rectification in candidate's registration applications, if any, in a separate sheet upto 03.05.2023 through E-Mail positively** to enable the HQrs. Office to carry out necessary rectifications and complete the further examination activities. Subsequently the Ink signed copy of the Board proceedings etc may be forwarded through Speed Post.

4. The Copy of withdrawal application by the candidates, if any, may also be sent by **07.05.2023 positively through E-Mail followed by Speed Post.**

5. The schedule of the examination will be notified shortly.
