Dear Ms. Prashad,

Department of Rural Development is currently implementing a number of major public funded programmes, including Mahatama Gandhi National Rural Employment Guarantee Scheme, Pradhan Mantri Awaas Yojana, Pradhan Mantri Gram Sadak Yojana and National Rural Livelihood Mission. The Department has been allocated considerable budget for this purpose. We have taken a number of initiatives, in collaboration and coordination with other stakeholder Departments, to make this public spending more transparent, encourage digital transactions and direct benefit transfer and to enhance accountability. Use of Public Financial Management System platform, customized software such as NREGASoft and AwasSoft to monitor transactions at every stage; Geo-tagging of assets, use of satellite based technology for work measurement are some of the initiatives adopted for effective programme implementation.

2. We are also strengthening the Internal Audit process so that feedback on our various programmes is received by us during the course of implementation and issues requiring interventions are identified in time to enable corrective action. In this regard, we have also constituted an Expert Advisory Group to suggest ways to accomplish the strengthening of Internal Audit. This group comprises senior officers from CGA, CAG and Administrative Services and will submit their recommendations very soon.

3. The Internal Audit personnel available with us are limited in number. In order to enhance our Internal Audit capacity, we intend to engage a number of retired officers with relevant experience. We have accordingly sought guidance from CAG and CGA for a panel of willing officers of the said organizations who have retired at the levels of Director, Deputy Secretary, Under Secretary or Section Officer to Government of India and have experience of audit and Internal Audit.
