The issue regarding relieving of AOs/SAOs who have been transferred but not relived till 01/07/2022 has been examined and it has been directed by the Competent Authority to cancel the transfer orders issued in respect of AOs/SAOs who have not yet been relived by your office, except the SAOs/AOs mentioned in Annexure-A attached to this letter (Hard Tenure station repatriation/posting cases). Therefore, the officers mentioned in Annexure-A may be relieved immediately.

2. It is also stated that relieving in respect of SAOs/AOs under PCA (Fys) Kolkata organization who are covered in the order issued by this HQrs Office letter No. AM/X/10062/6/2022, dated 11.07.2022 may be processed accordingly.

3. Further, consequent on cancellation of transfer order in respect of the AOs who have been promoted to the grade of AO as in-situ ( DPC-2021), it is requested that these officers may be utilized in the office/organization presently posted as AO and their case will be processed separately keeping in view of the administrative requirement.
