**Subject:** Review of IFA Setup: Indian Army, Indian Air Force, Indian Navy, Indian Coast Guard, DRDO & Border Road Organisation.

**Reference:** CGDA office's letter No. AN/III/3096/I/IFA/VOL. VI dated 23.02.2023.

The IFA structure notified by the CGDA office vide letter cited under reference, has been reviewed and revised on the basis of feedback/ suggestions received from IFAs, CDAs and Services.

2. Further, the IFA's jurisdiction for providing financial advice coverage to the units/ formations/ establishments has been defined in the IFA structure by adding one separate column under heading "Area of IFA Coverage" in the Annexures. However, the specific name of such units/ establishments has not been mentioned in area of IFA coverage being sensitive in nature.
3. The mapping of units/ establishments with IFAs has been accorded Service wise and Station wise. However, at stations having isolated small units/ formations/ establishments, the co-located IFA (of any Service) has been mapped with such unit/ formation/ establishment for providing IFA coverage locally.
4. In case of any overlap/ ambiguity regarding jurisdiction of units/ establishments vis-a-vis IFA coverage, the same may be referred to IFA Wing of HQrs. alongwith the request of unit for clarification and till such time IFA coverage may continue to be provided by the existing IFA so as to avoid disruption in processing the case.
5. The final IFA structure as re-notified under Annexure 'A', 'B', 'C', 'D', 'E', 'F' & 'G' includes the complete information of level of IFA, Manpower Authorisation, Link Officers, Administrative IFA, Proforma Controller and Area of IFA coverage in respect of Indian Army, Indian Air Force, Indian Navy, DRDO, Indian Coast Guard, Border Road Organisation & Nominated IFAs respectively.
