Subject: Promotion/Antedation of promotion from the grade of Auditor to the grade of Senior Auditor.

It has been requested vide this HQrs office circular bearing No. AN/XI/11060/Promotion/Corrs/2017 dated: 29/30.08.2017 to forward pending Antedation Cases along with photocopies of the relevant documents concerning each case including references of all previous correspondence and DPC cum Adjudication Report etc to this HQrs office for our further necessary action. In this regard some instances have been received in this HQrs office wherein antedation in promotion from Auditor grade to Senior Auditor grade is requested from the actual date of promotion against the vacancy year.

2. Attention is invited to the provisions contained in Ministry of Defence, Defence Accounts Department (Senior Auditor) Recruitment Rules, 2013[which came into force with effect from 21.09.2013], which stipulates that "Auditor in the scale of pay of Rs.5200-20200 plus grade pay Rs.2800 in the pay band-I with six years service in the grade rendered after appointment thereto on regular basis and successfully completed two week training in relation to the duties of higher posts imparted at various Regional Training Centers functioning under the department." Note 2 under Column 11 of the said rule further stipulates that "where juniors who have completed their qualifying or eligibility service are being considered for promotion, their seniors would also be considered provided they are not short of the requisite qualifying or eligibility service by more than half of such qualifying or eligibility service or two years, whichever is less and have successfully completed their probation period for promotion to the next higher grade along with their juniors who have already completed such qualifying or eligibility service."
