Subject: Promotion to the grade of Principal Controller of Defence Accounts (Higher Administrative Grade) alongwith transfer/posting in HAG of the Indian Defence Accounts Service.

Consequent upon the approval of promotion of the SAG officers, listed in **Annexure 'A'** to this letter, to the grade of Principal Controller of Defence Accounts of the Indian Defence Accounts Service (in the pay scale of Rs. 67000-79000/- (pre-revised) and level-15 of 7th CPC pay matrix), it has been decided by the Competent Authority to post them in the offices as reflected against their names. The promotion shall take effect immediately or from the date of assumption of charge, whichever is later. On assumption of charge, the officer (s) may be designated as Principal Controller of Defence Accounts/Principal Integrated Financial Adviser. Before assumption of charge on promotion by the officer(s), it may be ensured that no disciplinary/criminal case is pending against them.

2. The Competent Authority has also approved postings/transfers in respect of IDAS officers of Higher Administrative Grade as per **Annexure 'B'** enclosed to this order. The officer may be relieved immediately with the directions to assume charge at the new place of posting.

3. The officer(s) may also be requested that on reporting in the new office of posting, they may inform their date of joining, correspondence address, telephone nos. (Official, Residential & Mobile) and email id on an1-pinklist.cgda@nic.in for updation of the Civil List. Copies of the Part II Office Order effecting the promotion/transfer of the officer(s) may be sent to this HQrs. office.

4. PAR of the officer(s) till date of relief from the present charge/post may be initiated immediately in SPARROW system under intimation to HQrs office.

5. TA and joining time as admissible under rules may be authorized to the officer(s) as per the extant rules.
