3. The date of assumption of charge by the Officers may please be intimated to this HQrs office by Fax/email. The copies of Part II Office Orders notifying the assumption of charge and fixation of pay in the new grade may be endorsed to this HQrs Office separately.

4. These orders are in accordance with the DOPT OM No. 36012/11/2016-Estt (Res-I) (Pt. II) dated 15.06.2018. Officers may be informed that their promotion to Senior Time Scale of IDAS is subject to outcome of CWP No. 17376/2018, challenging the order of Hon'ble CAT Chandigarh bench dated 28.02.2018 in OA No. 060/00666/2017 filed by Shri Inder Kumar in the Hon'ble High Court of Punjab & Haryana at Chandigarh and SLP No. 30621 of 2011 in the matter of Jarnail Singh & others which is under consideration in Hon'ble Supreme Court. This fact may also be indicated in the Pt. II O.O. notifying their promotions.


