Subject:- Periodical review of performance of Government servants as per the provision of FR 56(j) and Rule 48(1) of CCS(Pension) Rules, 1972.

Reference is invited to DoP&T's OM No.25013/1/2013-Estt(A) dated 21/03/2014 and OM No.25013/01/2013-Estt.A-IV dated 11/09/2015 regarding periodical review of performance of Government servants with a view to ascertain whether the Government servant should be retained in service or retired from service in public interest before the age of 50/55 years or completion of 30 years of qualifying service, whichever occurs earlier as per the provision of FR 56(j) and Rule 48(1) of CCS(Pension) Rules, 1972.

2. As per para-10 of the DoP&T's OM No.25013/01/2013-Estt.A-IV dated 11/09/2015, the cases of Government servant covered under FR 56(j) and Rule 48(1) of CCS(Pension) Rules, 1972 should be reviewed six months before he/she attains the age of 50 years and on completion of 30 years as per the given calendar.

3. It is informed that DoP&T, being the nodal Department on the subject, is monitoring the issue and a report is required to be sent to DoP&T by the 15th of every month for the progress made in this regard for the preceding month.
