3. The said monthly report may also be furnished by 3rd of every month so that consolidated report may be forwarded to Ministry in time and may be noted in report and return chart of your organization.

Subject : Periodical review of performance of Government servants as per the provision of FR 56(j), FR 56(l) and Rule 48(1) of CCS(Pension) Rules, 1972.

Reference is invited to DoP&T's OM No.25013/1/2013-Estt(A) dated 21/03/2014 and OM No.25013/01/2013-Estt.A-IV dated 11/09/2015 regarding periodical review of performance of Government servants with a view to ascertain whether the Government servant should be retained in service or retired from service in public interest before the age of 50/55 years or completion of 30 years of qualifying service, whichever occurs earlier as per the provision of FR 56(j), FR 56(l) and Rule 48(1) of CCS(Pension) Rules, 1972.

2. As per para-10 of the DoP&T's OM No.25013/01/2013-Estt.A-IV dated 11/09/2015, the cases of Government servant covered under FR 56(j), FR 56(l) and Rule 48(1) of CCS(Pension) Rules, 1972 should be reviewed six months before he/she attains the age of 50 years and on completion of 30 years as per the given calendar.

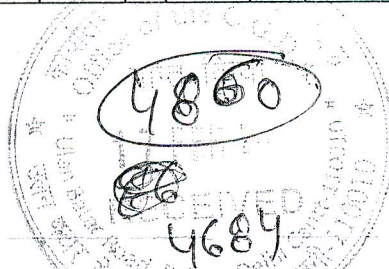
