Subject: Notes for the Cabinet/Cabinet Committees finalized on the basis of recommendations of appraisal bodies-consolidated instructions reg.

In continuation to Cabinet Secretariat O.M. No. 1/13/2/2008-Cab. dated 17.10.2014 clarifying procedural aspects relating to proposals considered by various appraisal bodies, it has been decided that all the notes submitted for the consideration of appraisal bodies [such as Expenditure Finance Committee (EFC), Public Investment Board (PIB), Core Group on Disinvestment (CGD), Expanded Board of Railways (EBR), Foreign Investment Promotion Board (FIPB), Public Private Partnership Appraisal Committee (PPPAC), Telecom Commission (TC), High Powered Committee for road projects under the Special Accelerated Road Development Programme for North East (HPC) etc.] should henceforth clearly indicate, under a distinct 'heading'/paragraph, the Employment Generation Potential of each proposal. All appraisal bodies must make it a criterion for appraisal of the proposal before it, and appraise this aspect carefully while considering the proposal. The minutes of the meeting of such appraisal bodies should also separately and clearly reflect the Employment Generation Potential of each proposal.

2. It is requested that the above instructions be disseminated to all concerned for strict compliance on an immediate basis.
