**Subject: Revision of seniority & antedation of promotion in various grades.**

Various proposals for revision of seniority & antedation of promotion in various grades is under examination in this HQrs. In this context, it needs to be appreciated that fixation of inter-se-seniority has serious impact on promotion in each grade and therefore utmost care has been taken to approve the promotion on the basis of seniority-cum-fitness basis subject to availability of vacancies in the grade with limited resources of manpower in the department. However, consequent upon revision of seniority in various posts of Group 'B' and Group 'C' on the basis of merit position assigned by the SSC during couple of years, lead request for antedation of promotion in various grades by the effected individual(s).

It appears from the communications received from the PCsDA/CsDA that the concerned PCDA/CDA has not yet identified the cases, where revision of seniority / antedation of promotion is required based on SSC Zonal/ All India rank. However, they are sending cases in piece meal manner, which may result in issuance of erroneous antedation of promotion and may also invite recovery of Pay & Allowances at later stage as well as change of seniority in the higher grade at short intervals.

As such, the PCsDA/CsDA are requested to asses all such cases in their organization and examine as per extant rules/orders on the subject. Accordingly, consolidated grade wise cases with relevant documents may be forwarded to this office latest by 31/12/2015 in the proforma enclosed, instead of sending the cases in piece meal, for necessary action. Cases received till date have been kept in abeyance to avoid any repeated change lateron, as more alike cases can also be there.
