
The following facts brought out with regard to the posting of AAOs in different PIFA/IFA offices have been noted by DAPB.

2. Earlier HQRs. had issued attachment order of 21 AAOs listed in annexure "A" to various offices of PIFA/IFA on 06/07/2015 initially for three months, keeping in view the demand raised by concerned PIFA/IFA in the light of new delegation of financial powers to Defence Services 2015.

3. However, the services of these AAOs are still required as work in IFA offices has increased in manifold due to delegation of financial powers to Defence Services 2015.

After considering all the facts mentioned above, DAPB recommends that 21 AAOs listed in Annexure "A" may be posted to their respective office as earlier attached. Further it is also recommended that if any AAOs stand transferred to other offices, their transfer order may be treated as cancelled.




