Subject: Filling up the two posts of Whole-time Member on the Board of Interim Pension Fund Regulatory and Development Authority

Sir,

The Government of India shall be filling up the two posts of Whole-time Member on the Board of Interim Pension Fund Regulatory and Development Authority (PFRDA), located in New Delhi. Interim PFRDA was established to develop and regulate the pension market, through a Government Resolution No.5/7/2003 ECB dated 10th October, 2003 which was subsequently re-issued vide Resolution No. 1(6)/ 2007-PR dated 14th November, 2008.

2. The tenure of appointment to the post shall be 5 years from the date of joining office with a provision of reappointment subject to the maximum age of 62 years. The pay and allowances of the Whole-time Member shall be Rs.3.125 lakh per month without facility of house and car. The terms and conditions of pay, DA, CCA, TA, PF, Pension etc. shall be governed by the Government Resolution Nos.5/7/2003 ECB dated 10th October, 2003 and Resolution No. 1(6)/ 2007-PR dated 14th November, 2008.

Eligibility:

- a) Post Graduate or a professional degree in economics, finance, law and any other professionals from the field of pension / actuaries / insurance / finance;
- b) Not less than 25 years of post qualification experience of which at least 15 years should be in the relevant field;
- c) Applicant should have a minimum of two years of residual service on the last date of submission of application i.e. not in excess age of sixty years;
- d) Should be a citizen of India

- i. Up-to-date and complete Confidential Report (CR) dossier in original / attested photocopies of last 5 years Annual Confidential Report (ACR) of the candidate,
- ii. Integrity Certificate,
- iii. Vigilance Clearance including certification that no disciplinary proceedings or criminal proceedings are either pending or contemplated against the officer concerned,
- iv. List of major / minor penalties, if any, imposed on the candidates during the last ten years / no penalty certificate.

5. The applicant should have a minimum 2 years of residual service as on 1st August, 2013.
