(iii) With 3 years' service in the grade rendered after appointment thereto on a regular basis in the scale of pay of Rs.14300-18300/- (pre-revised) revised to PB-IV Rs. 37400-67000 + GP 8700 or equivalent in the parent cadre/department;

[Period of deputation including period of deputation in another ex-cadre post held immediately preceding this appointment in the same or some other organization/department of the Central Government shall not exceed 5 years. The maximum age limit for appointment by deputation shall not be exceeding 56 years as on the closing date of receipt of applications].

 (ii) With 5 years' regular service in posts in the Pay Band 3 Rs.15600-39100+Grade Pay Rs.6600 or equivalent, or
 (iii) With 10 years regular service in posts in the Pay Band 2 Rs.9300-34800+Grade Pay Rs.5400 or equivalent.
