**Subject:** Constitution of Defence Accounts Placement Boards for implementation of Supreme Court's judgment dated 31/10/2013 in WP (civil) No. 82/2011.

**Reference:** Preceding notes.

As directed on preceding note, the Chairman DAPB was requested to intimate the convenient time and date to convey the first meeting of the DAPB.

2. Accordingly, the first meeting of the DAPB was convened on 04/07/2015 at 10:00 AM in Kautilya Hall of HQrs office.

3. A comprehensive policy framework of transfer for IDAS officers is not yet in place. The DAPB in its first meeting has laid down certain guiding principles for transfer/ posting of IDAS officers upto NFSG. These guiding principles will be dovetailed to a broader policy framework for IDAS officers' placements taking into account the various relevant parameters, which shall be undertaken immediately. This policy framework will take some time. Since transfers cannot wait finalization of the policy framework, The DAPB in its first meeting considered 4 cases effecting 7 officers.

4. The recommendations of the DAPB are placed opposite for perusal and approval of the Competent Authority.

5. In case approval of the minutes of DAPB in toto, additional charge of AAO (Pay) Leh/ IFA 14 Corps Leh is required to be assigned to Sh. Gurmail Singh, IDAS presently posted as AO (P) Himank.

6. The charge of PAO (ORs) PRC Ramgarh may be assigned to Shri Sameer Nairantarya, IDAS presently posted at PAO(ORs) SRC, Ramgarh.

**Minutes of Defence Accounts Placement Board meeting held on 04<sup>th</sup> July 2015.**

The Defence Accounts Placement Board (DAPB) as constituted vide AN/I/1201/SC/82/2011 date 16/06/2015 met on 4<sup>th</sup> July 2015 at 10:00 AM at HQrs office, New Delhi.

2. The full Board was present for the meeting.
3. The Board at the outset resolved to adopt certain guiding principles for considering transfer/posting cases brought before the Board. These guiding principles are placed as Annexure to these minutes.
4. Having decided the guiding principles, the Board took up the following cases for consideration:
  - i. Sh. Arvind Khare, IDAS
  - ii. Sh. S K Ghosh, Sr. AO (on promotion to IDAS)
  - iii. Sh. A C Khare, Sr. AO (on promotion to IDAS)
  - iv. Sh. D S Bansal, IDAS
5. The DAPB makes the following recommendations after considered deliberations:

Sl. No.	Brief description of the case	Recommendations
1	Sh. Arvind Khare, IDAS, CAT (PB) New Delhi vide its order dated 29/05/2015 on OA /1391/2015 and MA/1957/2015 had directed CGDA to examine the feasibility of adjusting Sh. Khare in a vacancy, if available at Delhi.	The officer has requested for retention on the grounds that his 10 year old is afflicted with Cerebral Palsy and is undergoing specialized treatment. In pursuance of CAT (PB) New Delhi order dated 29/05/2015, the Board noted that there is vacancy in Delhi at the level of NFSG/JAG. The Board further noted that the DOP&T guidelines issued vide OM No. 42011/3/2014-Estt.(Res) dated 06/06/2014 regarding posting of Govt. employees, who have differently abled children, have interalia, provided for exemption of such employees from routine exercise of transfers/ rotational transfers subject to administrative constraints. The ibid OM amongst others specifically includes cerebral palsy in the definition of disabled. In view of the foregoing the Board recommends that Sh. Arvind Khare, IDAS may be posted to PCDA(R&D) New Delhi vice Smt. Kavita Garg, IDAS. Smt. Kavita Garg, IDAS may be posted to office of the CGDA against the existing vacancy in that office.

		The Board further noted that Sh. Khare has already completed more than 5 years at Delhi and has residual service of 20 years. His retention at Delhi cannot be indefinite. Accordingly the Board recommends that his case may be reviewed along with the rotational transfers in 2017.
2	Sh. S K Ghosh, Sr. AO CAT, Kolkata vide its order dated 15/05/2015 on OA No. 351/000757/2015 has directed to consider the representation dated 06/04/2015 and to pass a reasoned speaking order in accordance with law within a period of one month from the date of communication of the order. Till such time the officer shall not be released from present place of posting.	The officer has requested for retention at Kolkata on promotion to JTS of IDAS on the grounds that he is a chronic diabetic and hypertension patient. He has also represented for posting to Kolkata on grounds of his spouse working in the office of AO MSF, Ishapore. The Board noted that his case would not merit favorable consideration in the normal course. However, the Board also noted the there are existing requests for posting to Delhi on repatriation from Hard/Tenure stations as per the guiding principles adopted by the Board. Keeping the foregoing in view the board recommends following transfers. i. Sh. SK Ghosh, Sr. AO to be retained at Kolkata against the vacancies in JTS/STS available in PCA(Fys)/OFB. ii. Sh. DC Devrani, IDAS, who has completed 2 years at Shillong and requested for Delhi, may be posted to IFA (A-Q) New Delhi vice Sh. SK Ghosh, Sr AO. iii. Sh. Jaswant Singh, IDAS presently posted at Ramgarh since October 2011 and has requested for posting to Shillong maybe posted to IFA (HQrs EAC) Shillong vice Sh. DC Devrani, IDAS. iv. Sh. K J John Kutty, IDAS has completed 2 yrs at AAO MES Port Blair and requested for posting to Delhi, which is not considered since he is due to superannuate on 30 Sep 2015.

### Guiding Principles for transfer/Posting of IDAS officers upto NFSG

1. The present DAPB constituted vide notification no. AN/I/1201/SC/82/2011 date 16/06/2015 for considering transfer/ posting of IDAS officers up to NFSG level, in its first meeting on 4<sup>th</sup> July 2015, resolved to adopt the following principles :
- i. Cases for transfer/ posting will be categorized in to following categories:
    - Regular/ rotational posting including transfers on promotion.
    - Medical cases.
    - Court Cases.
    - Request cases.
    - Any Other Case.
  - ii. For regular and request cases the following criteria would be considered as enumerated below:

Sl. No.	Criteria	Principles to be adopted
1	Station Tenure	i. Repatriation on completion of tenure at Hard/ tenure Station*. ii. For all other stations except Delhi, maximum continuous tenure to be 4 years. iii. For Delhi except HQrs Office, maximum continuous tenure to be 4 years. iv. For HQrs office maximum continuous tenure, including tenure at other offices in Delhi, to be 5 years. v. For officers reverting from deputation (at all stations including Delhi) maximum continuous tenure including deputation tenure to be 7 years.
2	Educational Grounds	Request for retention in the same station, if the child of the officer is in Class X or XII, will be considered for relevant academic year only. In cases where the child is in Class XII, retention will be considered up to July end of the calendar year of Class XII Examination.
3	Spouse in Govt. Service and Medical Cases	In accordance with extant DOP&T guidelines.
4	Residual Service	No transfer except on request during last year of service before superannuation. This will apply also to promotion cases.

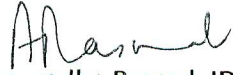

5	Rotational Transfers	All rotational transfers may be taken up during Jan/Feb of the Calendar year for implementation by April so as to coincide with new financial year as well as school academic year.
