The case in respect of request of Smt. Shylaja Dange, SA for transfer of her husband, Shri VV Dange, Sr.AO from CFA(Fys) VF Jabalpur to Nagpur has been considered by the DAPB.

2. The following facts have been brought to the notice of the DAPB:

- (a) Shri VV Dange while serving as AAO in PAO (Ors) Guards, Kamptee was approved for promotion to the grade of AO vide HQrs promotion order dated 21-01-2011 and transferred to AO (VF) Jabalpur, where he joined on 10-05-2011.

- (b) In October 2011, the officer requested for transfer to Nagpur/Ambajhari in view of the **PERSONAL INFORMATION** His request, however, could not be acceded to as there were no vacancies in Nagpur/Ambajhari (Note 1&2 ante). Moreover, his **PERSONAL INFORMATION** by the competent authority on the same ground.

- (c) In February, 2012, Shri VV Dange, SAO submitted another request for transfer to Nagpur citing the same reasons. The request was considered by the competent authority vide note 4 ante. Again, owing to unavailability of vacancies at Nagpur, his request was turned down. However, he was approved for attachment with JCDA (AF) Nagpur for a period of two months.

- (d) Since then, the officer has time and again requested for transfer to Nagpur through Half Yearly Reports as well as individual applications.
- (e) **PERSONAL INFORMATION** under Factories command vide orders dated 14.10.2011 on the same grounds.

The DAPB has gone through the case and opines that Shri VV Dange, SAO should be accommodated in Nagpur based on extreme compassionate ground due to loss of his elder son in road accident and treatment of younger son who is under psychiatric treatment due to death of his elder brother. DAPB recommends that Shri VV Dange, SAO may be posted to IA Cell, Accounts Office (OF) Ambajhari (Nagpur).
