
The case has been considered by the DAPB. The following facts have been brought to the notice of the DAPB:

It is intimated that the request for transfer to Coimbatore/Sulur in respect of Shri PS Raman, SAO has been considered by the Defence Accounts Placement Board (DAPB). The DAPB after considering the case recommended that the name of Shri PS Raman, SAO may be included in the Half Yearly Volunteer Report for April 2015 and the officer may also be asked to submit two more choice stations as per para 3.1 of Transfer Policy for his early repatriation. Therefore the Competent Authority, on the basis of the recommendation of the DAPB, has not been acceded to the request of Shri PS Raman, SAO regarding transfer to Coimbatore/Sulur. The case has been considered by the DAPB. The following facts have been brought to the notice of the DAPB:

- i. Shri A.K.Sahu, SAO was posted to NLAO (A) Mumbai locally on reversion from AO GE NW Mankhurd, Mumbai on 27.04.2015.
- ii. Subsequently, he was posted to AAO (ANC) Port Blair being a volunteer and his transfer order to NLAO (A) Mumbai was cancelled.
- iii. Shri A.K.Sahu has now stated that he has undergone Hip Replacement on 16.04.2015 and has now resumed duty on 25.04.2015. Presently he is not in a position to commute through local train or buses as he still needs support of a walker/stick for walking. Doctor has advised him for regular medication, exercise and physiotherapy.

The DAPB has gone through the case and observed that the officer has since resumed duty on 25.04.2015. Further Shri A.K.Sahu, SAO has been posted to Port Blair being a volunteer. The representation of the officer for retention in Mumbai has no recommendation of the PCDA/Jt.CDA. In view of the above, DAPB recommends that the request of Shri A.K.Sahu, SAO for cancellation of his transfer to Port Blair and retention in Mumbai may not be acceded to.
