Subject: Promotion of Clerks to the grade of Auditor.

The Competent Authority has approved the promotion of Clerks as per Annexure 'A' to 'E' attached, based on the vacancies available in the grade, who have been recommended 'Fit' by the DPC held in your office, to the grade of Auditor in the pay scale of Rs. 5200-20200/- (PB-I) with a grade pay of Rs. 2800/- w.e.f. the date mentioned in the Annexure or from the date of assumption of charge of higher post, whichever is later with all consequential benefits, in the same organization, where they are serving at present.

2. The promotion may be notified in the name of PCDA/CDA as Appointing Authority in the Office Order. Before promoting the individuals, it may be ensured that none of the circumstances enumerated in Para 2 of the DOP&T OM NO. 22011/4/91-Estt.(A) dated 14/09/92 have arisen before promotion. If such circumstances have arisen, the promotion shall not be released and instead treated as "Deemed Sealed Cover" case in terms of Para 7 of the said OM. At the time of notification of their promotion it may also be ensured that they are not undergoing penalty i.e., reduction to the lower stage of scale of pay or stoppage of increment etc. If the promotion is not notified for any reason, this fact may be brought to the notice of this HQrs. Office immediately.

3. PCsDA/CsDA are requested that before releasing the promotion of the individual(s), the earlier notification of promotion to the grade of Auditor on passing the departmental examination etc., effected from latter date, may be cancelled by notification of Part II OO.

Further, it has been observed that some of the Controllers have raised doubts as to whether the individual, who had earlier been promoted to the grade of Auditor based on the departmental examination will be adjudicated or not as they have already been promoted to the grade of Auditor. It is clarified that since, they are now eligible for the promotion to the grade of Auditor before their promotion based on departmental examination, accordingly, they should be adjudicate on completion of 8 years as per

criteria laid down in Hqrs letter dated 09/09/2014. As such, the necessary action to adjudicate the left over individual(s) may be taken at the earliest.

4. Before promoting the individuals, the Controllers are requested to ensure that they have either passed the typing test or are exempted from typing test in term of DOP&T OM No.14020/3/95-Estt(D) dated 14.09.1995 read with DOP&T OM dated 29.09.1992 and accordingly, the action as deemed fit may be taken in terms of these OMs.


5. Cases of refusal of promotion, if any be dealt with by the Controllers themselves in their capacity as an Appointing Authority in the light of provision contained in DOP&T OM No. 22074/3/81-Estt(D) dated 01.10.1981 and our circular No. AN/XII/12201/0/3/87 dated 24.11.87.

6. While issuing orders of promotion, attention of the individuals may please be drawn to the provisions of Ministry of Personnel, Public Grievances and Pension (DOP&T) OM No. 1/12/97-Estt.(Pay-I) dated 23/4/99 and clarification No. 2 of GOI, Ministry of Finance, Department of Expenditure No. 01/01/2008-IC dated 13.09.2008 regarding exercising of an option by them for fixation of their pay as Auditor.

7. The individuals at annexure 'F', who have not completed the requisite service of eight years as on 1st January have been adjudicated as 'Fit' by the DPC. This requires review based on the criteria laid down in Hqrs office letter dated 09/09/2014.


8. Further, if any discrepancy is found in notification of this promotion list, the Controllers are advised to refer the matter to this office for necessary action.


