Subject: Promotion to the grade of Senior Time Scale (Group 'A') of the Indian Defence Accounts Service on regular basis.

Sixty nine officers (69) serving in the offices/organizations indicated against each in Annexure 'A' to this letter have been selected for promotion from the Junior Time Scale of the Indian Defence Accounts Service (Pay level 10 of 7<sup>th</sup> CPC Pay Matrix) to the Senior Time Scale (Pay level 11 of 7<sup>th</sup> CPC Pay Matrix) of the Indian Defence Accounts Service on regular basis with effect from 01.01.2023 or from the date of assumption of charge in STS, whichever is later.

II) dated 15.06.2018, the above promotions shall be subject to further orders which may be passed by the Hon'ble Supreme Court on account of interim orders/directions in Special Leave to Appeal (C.) No. 30621/2011 (Jarnail Singh & Ors Vs Lachhmi Narain Gupta & Ors.) arising out of final judgement and order dated 15/07/2011 in CWP No. 13218/2009 passed by the Hon'ble High Court of Punjab & Haryana and Special Leave to Appeal (c) No. 31288/2017 arising out of Hon'ble Delhi High Court judgement dated 23/08/2017 and Hon'ble Supreme Court order dated 27/11/2017 in SLP (C) No. 17491/2017 (UOI & Ors v/s Sanjeev Malhotra & Ors) and Hon'ble High Court of Punjab & Haryana at Chandigarh order dated 06/02/2017 in CWP No. 24671 of 2016 (Union of India & Ors v/s Shaneel Rana & Others) and other related court cases.
