Subject: **Promotion of Auditors to the Grade of Sr. Auditor**

18 (Eighteen only) Auditors listed in Annexure "A" to this letter, who have been recommended as "Fit" by the DPC held in respective offices, have been approved for promotion to Sr. Auditor's grade in the pay matrix 6 (erstwhile PB – II with grade pay Rs. 4200/- as per VIth CPC) w.e.f **11.04.2017** or from the subsequent date on which they assume the charge. The promotion order notified by your office should also indicate that they have been promoted to the grade of Sr. Auditor by the PCsDA/CsDA as Appointing Authority in the promotion orders and Part II Office Orders.

2. The promotion of 22 (Twenty Two only) individuals listed in Annexure "B" of this letter, has also been approved w.e.f. 11/04/2017 or **date of successful completion of two weeks training, whichever is later. Controllers are requested to ensure that two weeks training as indicated in Recruitment Rules(RR) has been successfully completed before releasing the promotion order in these cases.**

3. The option for fixation of pay shall be exercised within one month from the date of assumption of charge of promotion, failing which they will be deemed to have opted for fixation of pay w.e.f the date of promotion in terms of DOP&T OM No. 1/12/97 Estt. (Pay-I) dated 23.4.1999 and clarification No. 2 of Govt. of India, Ministry of Finance F. No. 1/1/2008-IC dated 13.09.2008.

4. Before promotion, it may please be ensured that none of the circumstances enumerated in Para 2 of DOP&Ts OM No. 22011/4/91-Estt. (A) Dated 14.9.92, have arisen before promotion. If such circumstances have arisen the promotion shall not be released and instead treated as a "Deemed Sealed Cover" case in terms of Para 7 of the said OM. It may please be ensured that none of the Auditor, who is undergoing the period of penalty, is promoted till the expiry of the period of penalty. It is also requested to again re-check the service particulars of the individuals furnished in the adjudication reports to ensure their correctness.
