Subject: Promotion of MTS/Record Clerk to the grade of Clerks for the vacancy year 2021

The Forty four (44) MTS/Record Clerk serving in the organization indicated against each in Annexure to this letter who have been recommended as "Fit" by the DPC held in respective offices, have been approved for promotion by the Competent Authority to the grade of Clerk in the pay level 2 of pay matrix (as per 7th CPC) with effect from 01.01.2021 or from the date of assumption of charge of the higher post, whichever is later in the same organization where they are serving at present.

2. The promotion may please be notified in the name of PCDA/CDA as Appointing Authority in office order. Before promoting the individual, it may be ensured that none of the circumstances enumerated in Para 2 of the DOP&T OM No. 22011/4/91-Estt(A) dated 14.09.1992 have arisen before promotion. If such circumstances have arisen, the promotion shall not be released and instead treated "Deemed Sealed Cover" case in terms of para 7 of the said OM. The service particulars of the individual furnished in the adjudication report may again be rechecked to ensure its correctness.

3. If the promotion is not notified for any reason, this fact may be brought to the notice of this office immediately. The individual who have not passed the typing test will be eligible for increment only after passing the typing test through SSC or Hindi Teaching Scheme and they will further not be considered for promotion to the grade of Auditor before they either pass the typing test or get exemption from the typing test.

4. The Case of refusal of promotion, if any, may be dealt with by the Controllers themselves in their capacity as an Appointment Authority in the light of provision contained in DOP&T OM No. 22074/3/81-Estt(D) dated 01.10.1981. This HQrs office may please be informed accordingly.
