OFFICE MEMORANDUM

Subject:- Payment of Transport Allowance to Central Government Employees in Faridabad, Gurgaon, Ghaziabad and Noida.

It has been brought to the notice of this Ministry that some Central Government Offices located in Faridabad and Gurgaon are paying Transport Allowance to its employees at the rates other than that applicable to such areas and such payment is irregular. It is clarified that the Central Government Employees posted at Faridabad, Gurgaon, Ghaziabad and Noida are entitled to Transport Allowance at the rates applicable to 'other places' i.e. other than 13 classified cities as per the conditions laid down in this Ministry's O.M. No. 21(2)/2008-E-II(B) dated 29.08.2008.
