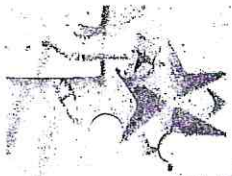

Hope this message finds you well.

I am writing to you regarding a marquee initiative that is transforming the space of public procurement in our country. As you may be aware, Government e-marketplace (GeM) is Government of India's initiative to provide an online, end to end solution for procurement of commonly used goods and services for all Central Government and State Government ministries, Departments, Public Sector units (PSUs) and affiliated bodies.

The Government e-Marketplace (GeM) was launched on 9th August, 2016 with the aim to facilitate procurement at the right price, right quality and right quantity in a transparent and efficient manner. The platform reduces manual process inefficiencies and human interventions in procurement and enables increased coverage, access and efficiency of faceless standardized public procurement. In a short period since inception, GeM has already achieved INR 37,623 Cr of Transaction Value, and has built a seller base of more than 298,646 sellers and service providers as on date 15th Nov 2019.

While GFR Rule 149 makes it mandatory for Central Ministries & Departments to procure commonly used goods & services through GeM, GeM endeavours to create impact on a much larger scale by on boarding Central PSUs and Public Sector Banks as well as State Governments. GeM has already signed MoUs with 23 states and 6 Union Territories to make procurement through GeM mandatory.

From the analysis of CPP Portal, it has been observed that you have now floated a tender enquiry for following item on CPP Portal.

As per the mandate of Government as mentioned in GFR, you need to procure all the products and services required through GeM portal only. It is therefore sincerely requested, that kindly cancels
