

Sir,

I am directed to refer to your letter 32013/ Indore-Goa/Sanction/ Mov C dated 17/05/2017 on the subject noted above and to state that vide Ministry of Civil Aviation O.M No. AV-18050/1/2017-AI dated 05.06.2017, in any sector, where Air India is not operating, the officers are permitted to travel by Airlines other than Air India and no approval for relaxation/ exemption is required for this purpose.

Further, Keeping in view the functional justification adduced in the letter No. 32013/ Indore-Goa/Sanction/ Mov C dated 17/05/2017, permission is accorded for the armed forces personnel to air travel Indore-Goa-Indore sector by airlines other than Air India Ltd. until Air India Ltd. starts operating in the aforesaid sector.
