Sub: Authorizing SAOs & AOs to accord concurrence within the IFA Set up.

Consequent upon introduction of Delegation of Financial Powers-2015, all procurement and Non-procurement powers in the schedules are to be exercised by the CFAs with the concurrence of the concerned IFA as per Para 12.1 of DFPDS-2015. The issue relating to authorizing some powers to SAOs & AOs was raised by field IFAs.

2. Accordingly, the Competent Authority has decided to authorize SAOs & AOs posted as dedicated IFAs to accord concurrence on the procurement proposals having financial implication upto Rs.10 Lakh, irrespective of the rank of CFA.
3. The above authorization is to be exercised by the SAOs & AOs posted as IFAs for Army/Navy/Air Force/IDS & DGAFMS, which are regulated by DFPDS-2015.
4. This issues with the approval of MoD (Fin) vide their No. File-CoordA-102/I dated 15.09.2015.
5. These powers are **not applicable for works cases.**
6. The SAOs & AOs have been authorized to accord concurrence on experimental basis and are subject to review after 3 to 6 months of implementation.

7. PIFAs/IFAs/Dy.IFAs under whose jurisdiction these lower IFA Offices headed by SAOs & AOs fall, will ensure that the proposals on which concurrence is accorded by the SAOs & AOs are examined in light with the provisions contained in DFPDS-2015, DPM-2009, Supplement-2010 and other Government orders on the subject.
