**Sub:** Determination of next higher CFA in cases of Full Powers.

References relating to determination of higher CFA where existing CFA delegated with full financial powers as per Delegation of Financial Powers of respective services and for projects specially sanctioned by the Govt. from time to time like MOLTI etc. are being received from various field IFAs positioned at Command / Services Hqrs. level.

2. The matter has been examined in consultation with Ministry of Defence (Fin) and it is hereby clarified that wherever full powers have been delegated to Defence Services in any schedule, the next higher CFA in such cases will be Ministry of Defence. All such cases may be referred by those CFAs to Joint Secretary concerned in MoD, dealing with the area of respective Defence Service.

3. In view of the foregoing guidelines, IFAs may deal with cases accordingly.
