Subject: Internet Connectivity – Policy Guidelines.

Reference: In continuation of this HQrs. Instruction Order No. 7 of 2008 bearing No. even dated 13.3.2008.

In para 4 of this office Instruction Order cited above, it was intimated that the matter regarding opening of a separate code head, under Minor head 110H – Information Technology, for booking of expenditure on account of access net works, media connectivity, internet connection including related hardware, software, maintenance and rentals, has already been taken up with MoD (Fin/Budget-I) by Accounts Section of HQrs. office. It was further mentioned that pending receipt of the clarification/amendment, expenditure on internet connectivity till 31.3.2008 may be concurred as per the existing practice and w.e.f. 1.4.2008, till such time the new code head is opened for this purpose, such expenditure be concurred under detailed head 574/01 as advised by MoD (Fin) and conveyed vide HQrs letter No. A/B/II/11244/Mont-army/Vol.I/P-87 dated 13.10.2005.

2. DGIS has brought out certain difficulties in operation of code head 574/01 for booking of expenditure on internet connectivity in view of the different Directorates delaing with the TAG and IT budget.

3. On reconsideration of the matter by this HQ in consultation with Jt.CGDA(Bud.& A/cs.), it has been decided that pending opening of the new code head by MoD (Fin.) the status quo for booking of expenditure on Internet Connectivity, i.e. Minor Head 110H-IT, may be maintained as per the existing practice in accordance with para 4 of DGIS guidelines dated 5.2.2007 viz. expenditure on internet connectivity may be concurred under code head 1/437/01 under Minor Head 110-H-IT.
