<b>Pay Scale Admissible</b>	<b>The pay scale admissible will be as drawn by the individual in accordance with the existing Central Government pay scales (PB1, PB1, PB2, PB3 and PB4 as applicable). There will be no change in pay scales of the individual on account of joining SSQAG. Deputation allowance is admissible as per the extent orders/guidelines issued from time to time.</b>
<b>Duration of Deputation</b>	<b>Deputation tenure may be for an initial period of 03 years and as per the provisions issued on the subject from time to time.</b>

2) Application from willing and eligible SAOs with at least 2 years stay in the present station and having residual service of at least 4 years as on 25.12.2024 along with Integrity Certificate and details of major/minor penalty(ies), if any, imposed during the last 10 years, may be forwarded to this HQrs office so as to reach by **08.01.2025** positively.
